The main purpose of the Authority is prevention of, and redress for anti-competitive practises in the economy. The Authority requires the services of a knowledgeable, highly skilled and self-driven citizen to apply for the following position:

Position Title: ANALYST - MERGERS AND MONOPOLIES

MAIN PURPOSE OF THE JOB

To implement policies and strategies to facilitate enforcement of the Competition Act, to facilitate the prevention, redressing and removal of anti-competitive practices which may be effected by mergers, acquisitions and monopolies in the economy.

KEY PERFORMANCE AREAS

- 1. Ensure appropriate notification/filling process and guidelines for qualifying mergers and acquisitions in the Botswana economy.
- 2. Evaluation/assessment of notified mergers and acquisitions and recommendation of appropriate decision.
- 3. Assessment of abuse of dominant market positions in the economy and recommendation of appropriate course of action.
- 4. Implementation of policies and strategies for the investigation, prevention, redressing and removal of anticompetitive practices in mergers and monopolies.
- 5. Effective application of competition law principles (utilisation of substantial lessening of competition test, abuse of dominance test and public interest considerations) and tests in the assessment of anti-competitive effects of mergers and monopolies.
- 6. Monitoring the competition effects of mergers and monopolies, post authorisation by the Authority.
- 7. Participation in public awareness on enforcement of mergers and monopolies

Experience: At least 5 years experience in market research and analysis, and

evaluation and analysis of economic data.
