

## **MERGER DECISION NO 6: 2016**

## DECISION ON THE PROPOSED ACQUISITION OF 100% ISSUED SHARE CAPITAL IN PENRICH INSURANCE BROKERS (PTY) LTD BY AFRICAN ESSENCE (PTY) LTD

PURSUANT to section 60(4)(a)(ii) of the Competition Act (Cap 46:09), notice is hereby given on the decision made by the Competition Authority in respect of the proposed acquisition of 100% issued share capital in Penrich Insurance Brokers (Pty) Ltd by African Essence (Pty) Ltd.

The Competition Authority determined through the analysis of the facts of the case, that the proposed transaction is not likely to result in the prevention or substantial lessening of competition, or endanger the continuity of the services offered in the market under consideration. The structure in the short-term insurance market will not be altered, and as such does not raise any competition concerns.

Pursuant to the provisions of section 55 of the Competition Act, the Authority has unconditionally approved the proposed acquisition of 100% issued share capital in Penrich Insurance Brokers (Pty) Ltd by African Essence (Pty) Ltd.

However, as stated under section 66 of the Act, this approval does not override or negate any other mandatory statutory approvals or processes that any of the parties to these mergers must comply with under the Laws of Botswana.
